### **Applications**

Entities interested in being listed as an Approved Service Provider, must submit an application form available on LPPM's website to [www.lppm.com](http://www.lppm.com) will email the main contact who submitted the application to let them know the outcome. If you are successful, the title of your auditing body and main contact's details will be added to our Approved Service Provider list. The process can take up to eight weeks from receipt of application.

### **International Branches**

Please note that for the global audit firms listed (such as Deloitte, KPMG or PwC), each international branch needs to be approved as an auditor separately. Each branch not listed as an auditor (“Non-Listed Branch”) will need to submit a separate application form, or alternatively, the Non-Listed Branch will need to have all their audits approved by a listed branch (listed branch refers to a branch approved as an auditor). However, we request that you initially approach the listed contact under each institution so that they may assist their colleagues directly.
