Auditing bodies shall submit an application supported by sufficient evidence, using the form below to demonstrate fulfilment of all of the LPPM's requirements detailed in the *Third-Party Audit Guidance*. The LPPM Physical Committee shall review the information and auditors/auditing bodies may provide any additional clarification as required by the Committee to support its decision.

The Committee shall regularly review the information submitted by auditing bodies in order to determine if any of the changes disclosed affect the auditing body's ability to remain on the LPPM list of approved auditing bodies. If necessary, the list of approved auditing bodies shall be updated with any changes.

<p>Complaints Mechanism The service provider must have the capacity to process appeals and/or handle complaints.</p>		
<p>Integrity / ethics The service provider must have a robust system in place to ensure integrity of all</p>
